# BACKGROUND

On August, 30, 2011, counsel for Boulder King Ranch Estates Water Company ("Boulder King") filed a notice of merger, noting that Boulder King is planning to merge with Boulder Farmstead Water Company ("Boulder Farmstead"). <u>See</u> Notice of Merger, filed August 30, 2011. On October 14, 2011, the Division of Public Utilities ("Division") filed a status report memo with the Commission. <u>See</u> Division Memo, filed October 14, 2011. The Division stated it had met with representatives of both Boulder King and Boulder Farmstead, and it was awaiting filing of copies of several documents, including:

- a) The Plan of Merger between Boulder King and Boulder Farmstead;
- b) Boulder Farmstead's current Articles of Incorporation;
- c) Boulder Farmstead's current Bylaws;
- d) Minutes from both Boulder King's and Boulder Farmstead's Boards of Directors meetings approving the Plan of Merger;
- e) Minutes from Boulder King's Shareholder Meeting held on August 31, 2011, and minutes from Boulder Farmstead's Shareholder Meeting held on September 10, 2011;

- f) A letter from an officer of both Boulder King and Boulder Farmstead each indentifying when the merger will be complete (or was completed), the impact, if any, to current customers, and what transferred (or will be transferred) as a result of the merger; and
- g) A letter to the Division of Corporations requesting dissolution of Boulder King.

See id.

On October 2, 2012, the Division filed a second memo recommending the Commission cancel Boulder King's certificate of public convenience and necessity ("CPCN") and acknowledge the merger between Boulder King and Boulder Farmstead. See Division Memo, filed October 2, 2012. However, as of that date none of the documents referred to above had been filed in this docket.

The Division subsequently filed a third memo which includes as attachments a variety of corporate governance documents describing the plan of merger and affirming its consummation as of December 1, 2011. <u>See</u> Division Memo, filed November 20, 2012. Accordingly, the merger is hereby acknowledged and Boulder King's CPCN should be canceled. Based on the examination and recommendation of the Division, Letter of Exemption #106 previously issued to Boulder Farmstead remains valid.

#### ORDER

Certificate #2254 previously granted to Boulder King Ranch Estates Water Company is hereby canceled.
