



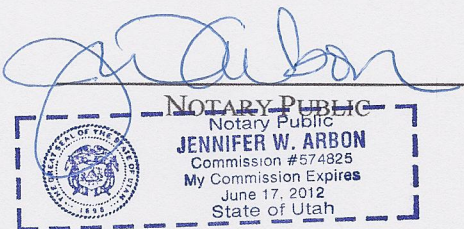

proper reserve is attained by proper channels, whichever comes first.

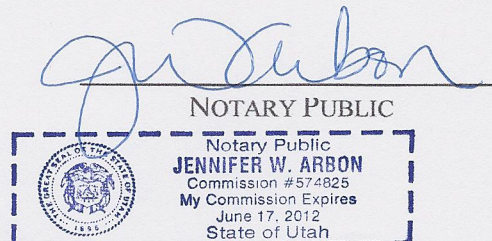
I strongly object to David Thompson paying for water

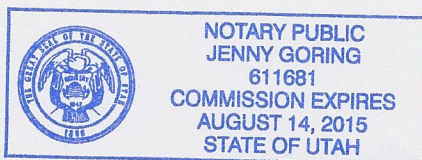

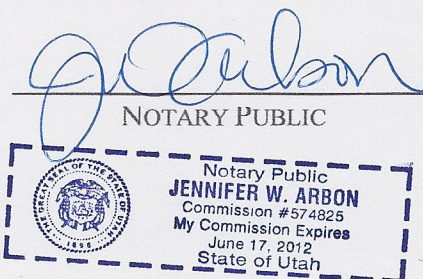
