This matter is before the Commission upon the recommendation of the Division of Public Utilities ("Division"), dated March 15, 2011, concerning Certificate of Public Convenience and Necessity (CPCN) No. 2369. The Division recommends cancellation of the CPCN based on information received from Mrs. Minnie Yoder ("Mrs. Yoder") of E & M Water.

In June 2001, the Commission issued CPCN No. 2369 to Mountain Valley Ranches Community Water Association, Inc. (the "Association"). Thereafter, the Association voluntarily dissolved on December 31, 2010.¹ At the time of dissolution eight (8) of the ten (10) customers previously receiving water from the Association were receiving water service from Central Iron County Water Conservancy District.

On January 1, 2011, the equipment and water system were transferred to Ed Yoder ("Mr. Yoder"), and Mr. & Mrs. Yoder established a new company under the name of E & M Water. On September 30, 2011, the Commission acknowledged the name change in Docket No. 11-2535-01.

In February 2012, Mrs. Yoder contacted the Division in response to the Division's

request for a 2011 Annual Water Report. Mrs. Yoder informed the Division in a letter dated February 9, 2012 that the well is private and only serves her husband and herself. Mrs. Yoder further clarified that no other customers are served by E & M Water.
