Hi-Country Estates Phase I Water Co. Rate Case

Gentlemen:

Docket No. 13-2195-02

I wish to file an objection to the rates being proposed by the Hi-Country Estates Water Company. The rates proposed are discriminatory to residents who conserve water in favor of those who use excessive amounts of water. In the second driest state in the nation, this is a practice that should not be encouraged.

I own a home in Hi-Country Estates Phase I and also the empty lot adjacent to it. I use an average of less than 5,000 gallons per month and have never — in 24 years — exceeded the 10,000 minimum water usage. I currently pay \$42.19 for water and a \$12.41 standby fee for the adjacent lot, for a total of \$54.60 per month. Under the proposed new rates I will be paying \$69.00 for water plus a \$20.09 Reserve Fund charge, and a \$27.60 Standby fee plus a \$20.09 Reserve Fund charge, for a total of 158.98 per month. That is an increase of \$82.18 or 150.5 %.

On the other hand, a user of 50,000 gallons per month will see his water bill go from \$158.89 to, under the new rates, \$162.79 – an increase of \$3.90 or 2.5 %. This customer will pay \$3.26 per 1,000 gallons. I will pay \$27.36 per 1,000 gallons. (See attached calculations.)

I submit that this is not fair. Users who conserve water should not be forced to support those who use much more. And that is even more important in a community who is asked to conserve water during the summer when the well pump cannot keep up with demand. I propose that the new Overage Rates be increased from old rates - not decreased, and that the new Base Rate be adjusted downward proportionately and that the minimum in the Base Rate be reduced or eliminated and a rate per gallon from that lower number be added.
