To whom it may concern:

Hi-Country Estates Homeowners Association ("Hi-Country"), in accordance with the Commission's July 12, 2012 Report and Order in Docket No. 11-2195-01, is now a regulated utility under Certificate of Public Convenience and Necessity No. 2737. After becoming a regulated utility subject to Public Service Commission jurisdiction, Hi-Country submitted its tariff on November 15, 2012. The advice letter accompanying that filing indicated that Hi-Country intended to make additional changes to the tariff as part of a general rate case; this filing is the result of the first of those changes.

This tariff, upon approval, will replace all pages of the tariff filed in 2012. Hi-Country submits this updated tariff to reflect changes suggested by Hi-Country's Board of Directors and legal counsel. Changes to the tariff generally include updates to numbering, formatting, and certain wording without material changes to the substance of the tariff. Other changes include, but are not limited to, clarifications regarding Hi-Country's relationship with certain customers, a statement of Hi-Country's obligations to provide water for fire protection, and modification of certain fee structures, including the addition of an interest change for late payments and setting a nonstandard connection review fee.

Hi-Country proposes that this tariff become effective 30 days after the date of this filing, or at an earlier date deemed appropriate by the Commission.

Hi-Country intends to file a general rate case in the near future and anticipates further updates and changes to the tariff as deemed necessary during the general rate case. Hi-Country also submits that the attached Tariff Sheets do not constitute a violation of state law or Commission rule.
