4	THE COURT: We'll be on the record. Welcome,
5	everyone. My name is Melanie Reif, and I'm the administrative
6	law judge for the Utah Public Service Commission. This hearing
7	is being held in Docket 13-2372-01, which is entitled, "In the
8	Matter of the Formal Complaint of Raphael Morris against South
9	Duchesne Culinary Water, Inc." This is in response to a
10	complaint that was filed by Mr. Morris.
11	And at this time, we'll start by taking appearances,
12	starting with Mr. Morris.
13	Mr. Morris, if you could kindly identify yourself and
14	spell your name for the court reporter.
15	MR. MORRIS: My name is Raphael Morris. First
16	name is spelled R-A-P-H-A-E-L, last name Morris, M-O-R-R-I-S.
17	THE COURT: Thank you. And on the telephone,
18	we have several individuals.
19	Mr. Schnars, could you please begin by identifying
20	yourself and spelling your name and indicating your association
21	with this case and your title.
22	MR. MIKE SCHNARS: Mike Schnars, M-I-K-E,
23	S-C-H-N-A-R-S. I'm the office manager for South Duchesne
24	Culinary water.
25	THE COURT: And on the line with you, you also

2	MR. MIKE SCHNARS: We have Jeff Schnars,	
3	J-E-F-F, S-C-H-N-A-R-S, who is the president of South	
4	Duchesne Culinary water. And we have Tosha Steed,	
5	T-O-S-H-A, S-T-E-E-D, who is the company secretary.	
6	THE COURT: Thank you very much.	
7	MS. STEED: Your Honor, would it be possible for	
8	me to tell you information I've received just this morning as the	
9	secretary from the courthouse?	
10	THE COURT: Am I speaking with Ms. Tosha	
11	Steed?	
12	MS. STEED: Yes, ma'am. That's me.	
13	THE COURT: Ms. Steed, yes. We would be willing	
14	to take your information. Are you willing to provide that	
15	information under oath?	
16	MS. STEED: Yes, ma'am, I am.	
17	THE COURT: Okay. Would you kindly raise your	
18	right hand.	
19	MS.STEED: Yes.	
20	THE COURT: And do you swear that the testimony	
21	that you are about to give is the truth?	
22	MS. STEED: Yes, ma'am.	
23	TOSHA STEED, having been first duly sworn, was	
24	examined and testified as follows:	
25	DIRECT TESTIMONY

1	THE COURT: And please proceed with the	
2	information that you wish to share.	
3	MS. STEED: The pertinent information that I've	
4	just received from Duchesne County records this morning is a	
5	warranty deed on Lot 25 in the Utah Mini Ranches Space 1.	
6	It turns out that Mr. Morris, Raphael, has	
7	transferred his property or sold it to someone else. That means	
8	he's actually been billed improperly. He didn't make us aware	
9	that he had sold the property. So what we are going to do is	
10	this happened, apparently, April 5, 2012. Bear with me I'm	
11	losing my voice. I've got a terrible cold. And actually South	
12	Duchesne started billing in July of 2012 for this fee he is making	
13	a complaint about. So I feel that that sort of makes this case	
14	moot. I'd rather not waste the Court's time.	
15	And we will start billing the correct property owner	
16	now that we have this new information that wasn't provided to us	
17	by Mr. Morris.	
18	THE COURT: Ms. Steed, thank you very much for	
19	your testimony. Is there anything further that you wish to add?	
20	MS. STEED: Not at this time.	
21	THE COURT: The warranty that you have been	
22	provided, you say it was executed on the 5th of April, 2012?	
23	MS. STEED: Yes, ma'am, that's correct. And the	
24	date it was actually filed through the courthouse, it went through	
25	April 9, 2012.

1	THE COURT: And again, the courthouse that you
2	obtained this document from is located where?
3	MS. STEED: In Duchesne County, Utah. I'll be
4	happy to fax the Court this copy, if necessary. I have it in my
5	hands. And it was notarized by, let's see, Brandon Pierce. His
6	Commission number is 577771.
7	THE COURT: Okay. So you have a certified copy
8	of a warranty deed indicating that Mr. Morris has conveyed his
9	property to a new owner, effective April 5, 2012.
10	MS. STEED: Yes, ma'am, that's correct. I don't
11	know if I actually hold a certified copy, but I do have a copy of
12	what they recorded up at the courthouse.
13	THE COURT: And it's been notarized, correct?
14	MS. STEED: Yes, ma'am, with Mr. Morris'
15	signature on it.
16	THE COURT: Okay. Ms. Steed, if you'll just hold
17	the line, please. I'd like to address this issue with Mr. Morris.
18	MS. STEED: Thank you very much.
19	THE COURT: Mr. Morris, were you able to hear
20	Ms. Steed's testimony?
21	MR. MORRIS: Yes, ma'am.
22	THE COURT: And do you acknowledge that on
23	April 5, 2012, you sold your property?
24	MR. MORRIS: I granted it over to my son.
25	THE COURT: Okay. Which makes you and your

1	son is the sole owner now?
2	MR. MORRIS: He is the sole owner, yes, ma'am.
3	THE COURT: Okay.
4	MR. MORRIS: I may add that I am representing
5	him because these are transactions these things happened
6	before then.
7	THE COURT: Okay.
8	MR. MORRIS: And my complaint is
9	THE COURT: Yes.
10	MR. MORRIS:something there that was not
11	justified or not following procedures that were entitled to me by
12	law.
13	THE COURT: Okay. And you're Raphael Morris,
14	right?
15	MR. MORRIS: Yes, ma'am.
16	THE COURT: And your son's name is?
17	MR. MORRIS: Gregory R. Morris.
18	THE COURT: Okay. Sir, under the circumstances,
19	I am going to dismiss your complaint as moot. The complaint is
20	in your name. And as Ms
21	MR. MORRIS: The correspondence is also in my
22	name from the Duchesne County.
23	THE COURT: The complaint is in your name.
24	There's no mention of any other second party. And the fact that
25	the property has been sold, this would be an issue for the new

1	property owner if the new property owner wished to make an	
2	issue of it. So there's	
3	MR. MORRIS: My problem is, is my son did not go	
4	through the procedures and was unexposed to this until I found	
5	that I need to transfer the property to him for his inheritance. In	
6	the meantime, all these things were happening, I could not get a	
7	response because he is naive and not knowledgeable at all of	
8	what was happening.	
9	And so now that you tell me that, I may have to get	
10	a Power of Attorney to represent him with the same complaint	
11	that he will have, probably, because this is also disturbing to	
12	him.	
13	THE COURT: Mr. Morris, you are welcome to file a	
14	second complaint if you choose to do so. Or should I add if	
15	your son chooses to file a complaint or if you wish to assist him	
16	in that manner that you've described, you're certainly not	
17	prevented from doing that. But under the circumstances, the	
18	way the complaint has been brought, and given the information	
19	that you are no longer the owner of the property and, in fact,	
20	weren't the owner of the property when the billing occurred	
21	MR. MORRIS: Why don't we change the title to	
22	"joint ownership"?	
23	THE COURT: Sir, I am not able to give you legal	
24	advice.	
25	MR. MORRIS: Okay. But if I do, will you guys

1	consider my testimony, my complaint?	
2	THE COURT: I'm not able to give you legal advice,	
3	sir, on how to change the title. But my understanding, based on	
4	Ms. Steed's testimony, is that title of the property is in someone	
5	else's name, and that makes your complaint moot. So the	
6	Commission	
7	MR. MORRIS: I understand that ma'am.	
8	THE COURT:the Commission dismisses the	
9	complaint. And this hearing is adjourned.	
10	MR. MORRIS: I understand that.	
11	THE COURT: Thank you.	
12	And thank you for all of those who have attended	
13	by phone.	
14	MS. STEED: Your Honor, could we get the case	
15	number on this for our records? As well as if you wouldn't mind	
16	relaying to Mr. Morris, given his threats of violence against	
17	individuals in this company, please do not contact, write, or	
18	come by this office, as we are definitely taking it as a threat.	
19	MR. MORRIS: I didn't hear that, ma'am.	
20	THE COURT: Ms. Steed, I don't have the ability to	
21	direct Mr. Morris beyond what I've already done in this case.	
22	MS. STEED: Yes, ma'am.	
23	THE COURT: And he's indicated that he did not	
24	hear what you said. So if you wish to communicate with him, I	
25	suggest that perhaps you find another alternative to do that.

1	MS. STEED: We now have no reason to speak to
2	Mr. Morris about anything again ever. Thank you.
3	THE COURT: Thank you, Ms. Steed. And were
4	you asking for the docket number? Is that what you were asking
5	for?
6	MS. STEED: Yes. If we could get that docket
7	number just so we could put it on our records and consider this
8	file and complaint closed. That would be helpful to us.
9	THE COURT: Yes. An order will be issued that will
10	confirm what we've discussed. And the docket number which
11	you can reference is Docket No. 13-2372-01.
12	MS. STEED: Thank you very much, your Honor. I
13	have that information.
14	THE COURT: And if it helps you, you can access
15	that docket via the Public Service Commission's website by
16	going to the home page and clicking on "Water." And then from
17	there, you go to the year of the docket, which would be 2013,
18	and then you scroll down to the proper docket number.
19	MS. STEED: Okay. And could you give me the
20	dot-com address on the Public Service Commission please,
21	ma'am?
22	THE COURT: Certainly. Do you have access to
23	Google?
24	MS. STEED: I'm sorry, I didn't catch that.
