I. **BACKGROUND**

On or about August 16, 2013, Raphael Morris ("Mr. Morris") filed a formal complaint in this docket against South Duchesne Culinary Water, Inc. ("Company"), requesting that a \$15 per month standby fee, which was approved by the Commission in 2003 but not charged by the Company until July 1, 2012, be removed or reduced until the property is developed or utilized.1 Mr. Morris also requested a justification for the fee and alleged the fee was being charged because the developer underestimated its costs.² In response to a Commission action request, the Division of Public Utilities ("Division") filed a recommendation on August 29, 2013, to schedule the matter for hearing.³

On October 1, 2013, the Administrative Law Judge for the Commission ("ALJ") held a duly-noticed hearing in this docket. Raphael Morris appeared on his own behalf. Jeff Schnars, water operator and president; Mike Schnars, office manager; and Tosha Steed, secretary, appeared telephonically on behalf of the Company. Both parties appeared pro se.

Ms. Steed testified the Company had obtained information from the Duchesne County Courthouse showing Mr. Morris had conveyed his property to a new owner on April 5, 2012; thus she alleged his complaint is most because the charge he complains of did not take effect until July 1, 2012, which is after he was no longer owner of the property subject to the standby fee being imposed.⁴ Mr. Morris confirmed he conveyed his property to his son on April 5, 2012, but he claimed his complaint represents both his and his son's concerns about the fee. 6 The complaint, however, lists only one complainant: Raphael Morris. Accordingly, the ALJ dismissed the complaint as moot.

II. **ORDER**

Based on the complaint filed, testimony presented, and for other good cause appearing, the complaint is dismissed as moot.
