Epic Engineering, P.C. serves as the City Engineer for the Town of Daniel, and has therefore composed this Notification of Dissolution of Storm Haven Water Company, Inc. for the Commission. Storm Haven Water Company, Inc. was dissolved and operations and infrastructure turned over to the Town of Daniel in August of 2015.

Assets obtained by the Town are listed in the attached report, along with the number of connections serviced, rates before and after the transfer of the Company, and necessary changes made by the Town after acquisition.

NOTICE OF DISSOLUTION OF STORM HAVEN WATER AND SEWER COMPANIES

Please be advised that both the culinary and sewer divisions of Storm Haven Water Company, Inc. in the Town of Daniel, Utah were dissolved and their infrastructure and maintenance taken over by Daniel Municipal Water in August of 2015. All assets were given to the Daniel Municipal Water System including the following items:

- 1. Three (3) Pumps
- 2. The existing culinary and sanitary sewer systems
- 3. The Storm Haven Company Bank account worth \$10,000

The Storm Haven Water Company serviced approximately 55 culinary water and sewer connections before being turned over to Daniel Municipal Water. Additional connections to the system are not anticipated in the foreseeable future,

Since Daniel Municipal Water has taken over the Storm Haven system, all three pumps obtained have failed and have been replaced with higher quality pumps at a cost of approximately \$7,000 to the Town of Daniel.

Further, the existing culinary water system obtained by Daniel Municipal Water was not up to code. Therefore, the Town of Daniel added a chlorinator disinfection system and increased the pressure of the culinary water system by upgrading the existing pressure tank and adding a second. Water rates for Storm Haven were increased to match typical rates for Daniel Municipal Water users, as shown in the table below.

Sewer Base Rate	\$9.00	\$16.00

The existing sewer and septic systems were up to code and in acceptable condition, and have therefore been left in place without upgrades.

In summary, both the culinary and sanitary sewer systems previously owned by Storm Haven Water Company, Inc. were turned over to the Town of Daniel in August of 2015. After significant upgrades to the existing systems, all Storm Haven neighborhood residents have access to safe drinking water and sanitary sewer services at Daniel Municipal Water monthly rates, effectively beginning regionalization of culinary and sanitary sewer water service in the area.
