My name is Art Brothers. I am submitting this signed petition to obtain Intervener Status on my own behalf in the pending rate case for Community Water Company – **Docket 16-098-01**. I am a long-time resident of Park West Village, a subdivision of mixed single-family homes and condominiums served by Community Water. As part of a volunteer community effort, I am working closely with neighbors, Bill Grenny and Van Martin to analyze the pending rate case. Bill is a retired engineer, Van is a retired Water Master and I have appeared before the Commission and worked with DPU staff on other regulatory matters. We have teamed-up to inform and help the approximately fifty single-family homeowners in Park West Village NOT represented by any active HOA understand the rate-case served by this docket. While not vested with any specific authority, for the past twenty years I have run a neighborhood eMail list used to form loose-coalitions of neighbors actively assisting each other on various planning, zoning, engineering and regulatory issues. In addition to working directly with Community Water and its parent company, TCFC, we are actively meeting with representatives of the various HOAs served by Community Water, other water companies as well as with Division of Public Utilities staff. Thus, I respectfully request Intervener Status.

In conjunction with this request for intervener status, I request access to copies of Community Water's Annual Report and Gross Revenue Reports for the past two years as well as any other associated documents, findings or filings to gain better understanding the financial condition of Community Water Company and the Division of Public Utility's development of the proposed rate.
