Ms. Matthews claims that she has 19 acre feet of water, but that Brooks Pace refuses to deliver her the excess water for her to water a pasture and sell the rest. She stated that her water right numbers are 81-4860 and 81-4861. This letter is in response to your complaint with the Division of Public Utilities. Thank you for the opportunity to respond to your concerns.

water from water user's claim No. Bl.-'1487, as stated on your Quit-Claim Deed. I have enclosed a copy of the Quit-Claim Deed that states that the twenty acre feet of water is restricted to irrigation use only and ONLY on lot being conveyed herein. The lot address being 1341 North Carter's Pond Rd.

I have also enclosed a copy of the CC&Rs for Old Farms Subdivision. Please see Article II, Residential Area Covenants item 11. Greenbelt Lots. It states that your Lot #5 is considered a greenbelt lot and the irrigation water is restricted to the use of irrigation only on the designated lot. These water rights CANNOT be transferred away from the lot. Please let me know if you have any additional questions, otherwise I will consider the case closed.

I am still traveling. Finishing up my mom's estate. Will be home next week. We need to have a conversation about my water deeds. The bank did not want or take the water on the Carter's Pond property. I had actually sequestered those water rights 4 years ago and spoke with Brooks at that time to transfer use to Horsemans Park. Now that the Carter's Pond house is fully out of my name I am again requesting use of that water on Horsemans Park. You may look up the deeds at the Cedar City office for the State Water Dept., they name me as the owner of two deeds, one for 16 feet of water and one for 3 feet. I actually deeded 1 acre foot of water to Carter's Pond. That will show up on the deed of sale for that house. I have spoken to the State Office in Salt Lake and the Cedar office and it looks like I actually own 19 acre feet of water and have every legal right to use it. My complaint to DVWW through the state is to be able to get DVWW to serve me that water. It doesn't really matter what Brooks did way back when because once the bank refused to take a deed for that water they gave up rights to it on that property. Once I am home we can deal with this. If service is still refused I will file another complaint and eventually request arbitration through the state. Filing a law suite is expensive and time consuming and if Brooks looses he stands to lose more than I do. Let's make this simple. Thanks Pat Matthews
