ORDER STAYING PRE-HEARING
FILING DEADLINES

ISSUED: May 26, 2017

On January 18, 2017, WaterPro Inc. filed a petition to increase its rates for culinary water. The parties participated in a scheduling conference on February 6, 2017, through which deadlines were set for the filing of pre-hearing testimony, motions, and disclosures.

On May 25, 2017, the parties informed the Public Service Commission of Utah (PSC) that they have reached a settlement agreement and no longer need to conduct discovery or file testimony.¹ The parties anticipate filing the settlement agreement with the PSC well ahead of the hearing, which is scheduled for Monday, August 7, 2017.

Given the foregoing, the PSC stays all pre-hearing deadlines set forth in the February 6, 2017 scheduling order. The PSC anticipates conducting the August 7, 2017 hearing solely to make a record of the parties' agreement and to take public comments, if any.
