It seems to me that this would not be public utility as it is owned by the state and does not sell water to the public generally.

Horrocks is seeking an affirmative response that this water system is not a public utility. I think that should come from the Commission rather than the DPU, Let me know if the Commission will respond.

The State of Utah is currently in the process of relocating the Correctional Facility to a new facility located west of the Salt Lake City Airport. Division of Drinking Water is requesting that a new Public Drinking Water System be created for this facility. Salt Lake City will provide wholesale water to the site and once delivered into the secure areas, the facility will have its own Public Drinking Water System managed and operated by Department of Corrections staff with certified operators. There will be no selling or billing of water service in this system.

DDW has asked that we contact Department of Public Utilities for a Letter of Exemption or approval that a Certificate of Convenience and Necessity is not required.

Please review the creation of this new system and respond if the PWS is exempt or regulated by DPU.
