On May 31, 2018, the Public Service Commission of Utah (PSC) opened this docket for the purposes of developing and adopting rules as required by the recently enacted Utah Code Ann. § 54-17-807, Solar Photovoltaic or Thermal Solar Energy Facilities. Pursuant to the PSC's May 31, 2018 Notice of Proposed Rulemaking and Request for Comments (Notice), parties filed comments and reply comments on June 29 and July 13, 2018, respectively. As requested in the Notice, PacifiCorp, doing business as Rocky Mountain Power (PacifiCorp) and Utah Clean Energy filed draft rule language with their reply comments. In addition, PacifiCorp and the Office of Consumer Services recommended the PSC convene a technical conference or informal workshop where parties can discuss the draft rules and comments, and possibly achieve consensus on draft rule language.
