On July 20, 2018, the Public Service Commission of Utah (“PSC”) held a technical conference in this docket. At the conclusion of the technical conference, participants expressed a desire to continue informal discussions and indicated they would file a draft rule with the PSC at the conclusion of those discussions. Participants discussed an expected timeframe, but the PSC did not establish a deadline.

Utah Code Ann. § 63G-3-301(13) requires the PSC to file a proposed rule, as mandated by Utah Code Ann. § 54-17-807(11), with the Utah Division of Administrative Rules no later than November 4, 2018, which would probably result in the publication of that proposed rule in the December 1, 2018 Utah State Bulletin.

The PSC gives notice that it will file a proposed rule with the Division of Administrative Rules by Friday, November 2, 2018, based on the input received in this docket. The PSC invites any interested participant in this docket to file a status update or additional comments on or before **Monday, October 15, 2018**, indicating the current status of informal negotiations.
