NOTICE OF PROPOSED RULEMAKING

On October 4, 2018, the Public Service Commission of Utah (PSC) issued a Report and Order (Order) in Docket No. 18-057-07.<sup>1</sup> In our Order, we committed to opening a separate rulemaking docket to “address proper use of utility customer lists, appropriate utility-related solicitation communications, use of monopoly utility branding, and other issues that may arise[.]”<sup>2</sup> We open these rulemaking dockets to establish those rules for electric and natural gas utilities whose rates of return are regulated by the PSC.

NOTICE OF SCHEDULING CONFERENCE
