Rocky Mountain Power ("Company") respectfully submits this Second Status Update to the Public Service Commission of Utah ("Commission") on behalf of the organizations that have participated in the informal stakeholder meetings, including the Company, the Commission, Division of Public Utilities, Office of Consumer Services, Salt Lake City, Summit County, Salt Lake County, Cottonwood Heights, Moab City, Millcreek, Park City, Utah Association of Energy Users, Utah Clean Energy, Western Resource Advocates, HEAL Utah, Interwest Energy Alliance, First Solar, Sierra Club and Wasatch Clean Air Coalition ("Participants"). The Company consulted with each of the Participants and all Participants agree with the content of this Second Status Update and the statements it contains.

As identified in the Second Scheduling Order, some of the foregoing Participants engaged in informal meetings on May 13, May 31, June 12, July 3, July 17, July 30, August 13, August 29, September 17, and October 10, 2019 to collaborate on draft rules. These active Participants expect to reach consensus on a common set of draft rules to submit to the Commission, which are anticipated to be final and ready to be filed on or before November 1, 2019. No other participant has informed the Company of any opposition to the draft rules.
