I understand that the proposed change was published on October only a proposed change, and may change prior to a final decision. Ideally, and typically, we are given at least 30 days from when a change occurs before a new fee is required to be collected Is it safe to assume the surcharge will be set at the new rate of 71 cents at some point between December 15<sup>th</sup> and December 29<sup>th</sup>? If so, we can go ahead and turn on the new rate now and for January 1, 2024. Please let me know when you have a chance. I've read through the proposed UUSF surcharge increase notice - 329895NtcPrpsdRuleAmndmnt9-19-2023.pdf (utah.gov). The notice states that public due by December 15, 2023, but also states that the rule change may become effective on December 29<sup>th</sup>. We're trying to ensure compliance with the posurcharge increase, but the turnaround time is very quick.
