*Rocky Mountain Power Comments Regarding Topics for March 12, 2024 Technical
Conference*

In accordance with Scheduling Order and Notice of Technical Conference issued on January 11, 2024, by the Public Service Commission of Utah (the “Commission”) PacifiCorp d/b/a Rocky Mountain Power (“RMP”) submits these comments to provide input on the topics to be discussed at the March 12, 2024 technical conference.

As discussed in the reply comments filed November 30, 2023, RMP has been developing default settings for smart inverters that will require UL 1741 Supplement SB, the testing standard that determines compliance with IEEE 1547-2018. The Company plans to implement default reliability settings, as well as enabling voltage controlling functionality within the inverter, to mitigate potential power quality issues and increase hosting capacity. The Company requests 30-45 minutes be reserved on the agenda for the March 12, 2024 technical conference to discuss plans for implementing default settings.

Rocky Mountain Power appreciates the opportunity to provide input to the Commission in this matter and looks forward to collaborative discussions with the Commission and stakeholders at the technical conference.


