After receiving initial stakeholder comments, the PSC held a scheduling conference on January 4, 2024, which resulted in a technical conference on March 12, 2024.

At the technical conference, Rocky Mountain Power offered a presentation addressing issues stakeholders had expressed interest in exploring, and the Interstate Renewable Energy Council also gave a presentation on issues it believes to be pertinent to any potential amendment of the Rule.

In light of stakeholders' filed written comments and the presentations heard at the technical conference, the PSC believes the next appropriate step is to invite stakeholders to submit proposed amendments to the Rule.

Accordingly, the PSC gives notice that any interested person may submit proposed amendments to the Rule on or before **Monday, May 13, 2024**. Stakeholders may submit written responses to these proposed amendments on or before
