Pursuant to Utah Code Ann. § 63G-3-305, the Public Service Commission (PSC) recently completed a five-year review of Rule 746-347 of the Utah Administrative Code, titled “Public Service Commission, Administration, Extended Area Service (EAS)” (“Rule 347”). Rule 347 applies to the establishment or restructuring of EAS or expanded EAS by incumbent telephone corporations. Based on the completion of its five-year review, the PSC seeks comments from interested persons regarding whether Rule 347 should be repealed.

Interested persons may file comments by **Thursday, March 23, 2023**, and reply comments by **Monday, April 24, 2023**.
