On April 15, 2024, the Public Service Commission (PSC) issued a notice in these dockets (“Notice”) regarding a draft rule increasing the Utah Universal Service Fund surcharge from \$0.71 to \$0.98 per access line. The Notice was published in the Utah State Bulletin on May 1, 2024. The Notice stated an anticipated effective date of July 1, 2024 for the proposed rule amendment, and that comments would be accepted until June 3, 2024. No comments were received.

Accordingly, we give notice that we intend to make the proposed rule amendment effective on July 1, 2024.
