S.B. 132, Electric Utility Amendments,¹ became effective on May 7, 2025.

Pursuant to Utah Code § 63G-3-301, the Public Service Commission (PSC) has 180 days following the bill's effective date to initiate rulemaking proceedings.^{2,3} To ensure draft rules are written in a timely manner, the PSC gives notice it will conduct a scheduling conference on **Thursday, May 22, 2025, at 1:00 p.m.** Parties should come prepared to discuss a schedule for this docket.
