Proposed Rulemaking Concerning Utah Code §§ 54-26-101 to -901, Large-Scale Electric Service Requirements	Docket No. 25-R318-01 Joint Motion to Amend Scheduling Order and Request for Expedited Treatment

Pursuant to Utah Administrative Code R746-1, the Division of Public Utilities, Office of Consumer Services, Utah Association of Energy Users, and Rocky Mountain Power (collectively the “Moving Parties”) file this Joint Motion to Amend Scheduling Order and Notice of Technical Conference (“Joint Motion”). The current scheduling order provides that interested parties may file initial comments or rule proposals by August 28, 2025, and reply comments by October 10, 2025. It also noticed a technical conference to be held on September 17, 2025.

To allow interested parties to better outline their positions on the proposed rules in this docket, the Moving Parties request the Public Service Commission of Utah (“Commission”) amend the scheduling order to allow stakeholders to file, by September 10, 2025, reply comments in response to parties’ initial comments. This additional comment deadline would give stakeholders the opportunity to provide comments on initial proposals before the scheduled

technical conference.

Finally, because of the compressed timeframe for this rulemaking proceeding and the fact that the time for briefing this Joint Motion extends past the initial comments date, the Moving Parties respectfully request expedited treatment of this Joint Motion.
