ORDER GRANTING JOINT MOTION TO AMEND SCHEDULING ORDER

ISSUED: August 21, 2025

On August 15, 2025, the Division of Public Utilities, Office of Consumer Services, Utah Association of Energy Users, and Rocky Mountain Power (collectively, "Moving Parties") filed a Joint Motion to Amend Scheduling Order ("Joint Motion"). The existing scheduling order ("Scheduling Order")¹ requires stakeholders to file comments by August 28, 2025, and reply comments by October 10, 2025. It also sets a technical conference to be held on September 17, 2025. The Scheduling Order reflects the stipulated schedule to which participating stakeholders agreed at the scheduling conference the PSC held on May 29, 2025.

The Moving Parties request the PSC modify the existing scheduling order to "allow stakeholders to file, by September 10, 2025, reply comments in response to parties' initial comments." They assert this "additional comment deadline [will] give stakeholders the opportunity to provide comments on initial proposals before the scheduled technical conference" and "to better outline their positions."

The PSC understands the Joint Motion to request an additional opportunity to submit comments responsive to initial comments, i.e. the Moving Parties are not requesting the PSC shorten the existing time frame for filing reply comments but that the PSC allow responsive comments on September 10, 2025, in addition to reply comments presently due on October 10, 2025.

Good cause appearing, the Joint Motion is granted. The Scheduling Order is amended to include an opportunity for any stakeholder to submit responsive comments on September 10, 2025. All dates and deadlines established in the Scheduling Order, including the noticed technical conference, remain unchanged.
