  - (b) partner with counsel licensed in Utah.

(emphasis added). Counsel are partners at the Denver office of the law firm of Holland & Hart LLP. Associated counsel, Chad Baker, is also a partner at Holland & Hart in the Salt Lake City office. Thor Nelson is licensed in Colorado, Montana, Nevada, and Wyoming. His certificates of good standing from Colorado is attached as Exhibit A, a certificate of good standing from Montana is attached as Exhibit B, a certificate of good standing from Nevada is attached as Exhibit C, a certificate of good standing from Wyoming is attached as Exhibit D. 
