PETITION TO INTERVENE

Pursuant to the provision of §63-46b-9 Utah Code (2003) and Rule R746-100-7 Utah Administrative Code (2003), of the Rules of Practice and Procedure of the Utah Public Service Commission, the Utah Energy Office (UEO) petitions for leave to intervene in the above-captioned docket and, in support thereof, states as follows:

1. The UEO is authorized by Utah Code Section 63-34-5(2)(2003) to participate in regulatory proceedings as appropriate to the functions and of the Department of Natural Resources, and appear on behalf of the State of Utah as an energy consumer before the Public Service Commission.
2. The UEO has an interest in the above-captioned proceeding because it is assigned statutory responsibility to facilitate the development and implementation of programs relating to energy conservation, energy efficiency and renewable energy. The outcome of this proceeding may impact the ability of developers of wind-powered generation to develop wind power in the State of Utah, the ability to protect ratepayers from double counting of

renewable energy certificates ("green tags"), and affect the incentive to develop clean, low-
cost resources for end-use customers.


3. Intervention by the UEO will not unduly broaden the issues or delay the proceeding.
