ORDER GRANTING RECONSIDERATION AND
GRANTING EXTENSION FOR FILING
SURREBUTTAL TESTIMONY FOR ALL PARTIES

ISSUED: September 14, 2005

By The Commission:

On September 12, 2005, Wasatch Wind filed a Petition for Extension for Filing Surrebuttal Testimony (Extension Petition) seeking to extend its deadline for filing of surrebuttal testimony to September 19, 2005. The Extension Petition was granted September 12, 2005. On September 13, 2005, PacifiCorp filed a Petition for Reconsideration (Reconsideration Petition), noting the effect that granting the Extension Petition will have on parties' time to prepare for the hearings that are scheduled to start September 22, 2005, and the disparate impact the extension has on the parties' preparation of prefiled written testimony.

We are mindful of the potential impact any extension has on the time available for parties to prepare prefiled testimony and prepare to participate in hearings before the Commission. In this docket we desire as much information and the best information which can be presented. In that light, we will grant reconsideration and give all parties additional time, to September 16, 2005, to prepare and file their written surrebuttal testimony. Doing so, we also recognize that this may again have an impact on the parties's ability to prepare for the hearings, especially those who would be presenting their witnesses early on in these proceedings. Because of that potential impact, we also inform all parties that they will be able to recall their witnesses, later in the hearings, to respond to the delayed, written surrebuttal testimony that will be filed; giving them added time to prepare their live testimony that may respond to the written surrebuttal testimony. We will also provide additional time for the hearings, a subsequent day to be scheduled if necessary, for all parties to have an adequate opportunity to respond to the extended date now given for the filing of surrebuttal testimony.

Based upon the Reconsideration Petition and for good cause appearing, therefore, the Commission makes the following

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED, that:

- The reconsideration request is granted.
- Wasatch Wind will file its Surrebuttal Testimony on September 16, rather than September 19, 2005.
- The deadline for all parties to file surrebuttal testimony is extended to September 16, 2005.
- All parties will be given additional hearing time to respond to the filed surrebuttal testimony.
