On March 21, 2005, Comcast Cable Communications submitted to the Commission its Proof of Pole Attachment Authorization in which it requested a refund of an additional \$455,760 in the captioned proceedings.

On April 20, 2005, PacifiCorp filed a Petition for Certification of Refund assert-

ing that the appropriate refund was \$318,060.

Subsequent to PacifiCorp's submission of its Petition, the Parties have engaged in negotiations regarding a final settlement of the refund amount owed to Comcast and have reached a tentative settlement that would resolve the refund issue in this case.

The Parties are in the process of drafting and finalizing the terms of a formal settlement agreement and a joint motion to the Commission to approve such a settlement. It is anticipated that these documents will be filed by the Parties sometime during the week of May31-June 3, 2005.

To the extent necessary to preserve Comcast's right to respond to PacifiCorp's Petition for Certification, the Commission may wish formally to stay the proceedings pending the filing of the settlement and motion to approve it.

PacifiCorp is authorized to represent that Comcast concurs with this Notice of Tentative Settlement.

WHEREFORE, PacifiCorp seeks such Commission action as may be necessary in the captioned proceeding to preserve the rights of the Parties until a full and final settlement is filed.
