Pursuant to Utah Code Ann. § 63-46b-9 and Utah Administrative Code R746-100-7, Calpine Corporation (“Petitioner”) hereby petitions for leave to intervene in these proceedings.

In support of this petition to intervene, Petitioner states as follows:

1. Petitioner operates wholesale electrical generation facilities throughout the United States and proposes to construct new generation facilities within the State of Utah. Moreover, Petitioner submitted bids in response to RFP-2003A issued by PacifiCorp.

2. The Application in this Docket seeks approval of PacifiCorp’s determination that its self-build proposal is the most economical option when compared to all RFP responses for at least one category of requested resource. It also requests a determination that the proposal is in the public interest and will not adversely affect any other public utility. The legal rights and interests of Petitioner may thus be substantially affected by this proceeding.

3. Petitioner has not determined the positions it will take in this matter, and seeks to intervene in order to protect its interests as they may appear.

4. The interests of justice and the orderly and prompt conduct of this proceeding will not be materially impaired by allowing Petitioner to intervene.
