**TEST PERIOD
AND SCHEDULING
STIPULATION MOTION FOR
APPROVAL OF STIPULATION
AND ISSUANCE OF NOTICE**

PacifiCorp hereby moves the Public Service Commission of Utah (the "Commission") for approval of the Stipulation ("Stipulation") dated January 7, 2004, a copy of which is attached hereto. In addition, the parties request that the Commission issue a notice of hearing in the form attached hereto setting a hearing for January 15, 2004 at 9 a.m. to consider approval of the Stipulation. In support of this motion, PacifiCorp represents as follows:

3.1. On May 6, 2003, the Commission issued its order establishing a procedural schedule for this case and approving a stipulation which resolved test period and rate effective date issues ("Test Period Stipulation").

2. On December 9, 2003, the parties filed a Revenue Requirement Stipulation which resolved all the revenue requirement issues in this proceeding. The net effect of the Revenue Requirement Stipulation is an average jurisdictional revenue requirement increase of \$65 million. The Commission approved the Revenue Requirement Stipulation orally at a hearing on December 17, 2003.

3. On September 15, 2003, in accordance with the terms of the Test Period Stipulation, PacifiCorp filed direct class cost of service, rate spread and rate design testimony. On October 31, 2003, PacifiCorp filed updates to its class cost of service and rate spread exhibits. On October 31, 2003, parties exchanged their initial lists of proposed cost of service,

rate spread and rate design issues. Cost of service, rate spread and rate design negotiations began on December 18, 2003 and continued on December 22 and 23, 2003. The negotiations were open to all parties.

4. As a result of those discussions, and based on their examination of testimony and data provided in discovery, the parties whose signatures appear on the signature pages of the Stipulation (the “Parties”) have reached a global settlement of all the cost of service, rate spread and rate design issues in this case.

5. The Parties submit that the terms of the Stipulation are just and reasonable and otherwise in the public interest.

WHEREFORE, PacifiCorp respectfully requests that the Commission grant this motion and approve the Stipulation and issue a notice of hearing in the form attached hereto.
