Pursuant to Utah Code Ann. § 63-46b-9 and Utah Admin. Rule 746-100-7, Comcast Cable Communications, LLC (“Comcast”) respectfully petitions the Public Service Commission of Utah (the “Commission”) for leave to intervene in the above-captioned proceeding concerning the application of PacifiCorp, doing business as Utah Power & Light

Company (“PacifiCorp”), for an order authorizing an increase in its rates for electric service in the state of Utah. In support of its petition, Comcast represents and states as follows:

1. Comcast is a provider of broadband communication services, which include traditional cable television services as well as information services, for residential and business customers throughout the state of Utah.

2. As a provider of these communications services, Comcast is a large user of electric utility services in Utah. In addition, Comcast has attached its communication facilities to PacifiCorp’s network of utility poles in the state and Comcast pays PacifiCorp pole attachment rent for this pole use. The rate adjustments requested by PacifiCorp with respect to electric revenue and joint use revenues could result in significant added costs to Comcast. Thus, Comcast’s legal interests could be directly affected by the outcome of this proceeding.

3. The interests of justice and the orderly and prompt conduct of this proceeding will not be impaired by allowing Comcast to intervene.

WHEREFORE, Comcast respectfully requests that the Commission enter an Order granting Comcast’s Petition to Intervene as a party in this docket, allowing Comcast to participate to the full extent allowed by the rules of the Commission and by Utah law.
