Pursuant to Utah Code Ann. § 63-46b-9 (1992) and Utah Admin. Code § R746-100-7, Wasatch Wind LLC hereby moves for leave to intervene in the above-referenced proceeding before the Public Service Commission of Utah. In support of this Motion, Wasatch Wind states as follows:

1. Pioneer Wind filed an application with the Commission for approval of its proposed Power Purchase Agreement (PPA) with PacifiCorp as a Qualifying Facility under PURPA on March 10, 2006.

2. Wasatch Wind is a wind developer that is currently negotiating with PacifiCorp for PPA for a project in Spanish Fork, Utah. As a potential Qualifying Facility and a participant

in the Docket Number 03-035-14, Wasatch Wind has a direct interest in these proceedings and the outcome may have a substantial effect on Wasatch Wind. Because of the early stage of this proceeding, Wasatch Wind has not yet determined what, if any, positions it will take on any issues raised, or what relief it may seek to protect its interests.

3. Wasatch Wind's interest in the outcome of these proceedings will not adequately be represented by any other party, nor will Wasatch Wind's participation impair the conduct of the proceeding.
