1. The entry of the proposed Protective Order on a facilitated basis will expedite and facilitate the exchange of information by the parties by affording protection to valuable, confidential, trade secret, and proprietary business information.

2. The proposed Protective Order is fair and equitable to all parties and provides the parties and the Commission with access to information while allowing for the protection of the integrity of confidential information.

3. The proposed Protective Order is in the same form as Protective Orders entered by the Commission in recent cases involving this and other utilities under its jurisdiction, including the Protective Order entered in PacifiCorp’s last general rate case.

WHEREFORE, PacifiCorp requests that the Commission enter the Protective Order in the form attached hereto on an expedited basis.
