2. Regarding data requests served prior to November 18, 2005, parties will respond within 10 business days.

Regarding data requests served on or after November 18, 2005, parties will respond within 5 business days. Data requests are considered served on another party such that the 10 or 5 business day turnaround (whichever is then-applicable) begins if they are served on the party to respond by electronic mail or hand delivery by noon on the day of service. If the data requests are served on the party to respond after noon, then the 10 or 5 business day turnaround begins on the next business day.

3. The participants shall, if possible, serve all filings by electronic mail.
