Pursuant to Utah Code Ann. § 63-46b-9 (1992) and Utah Admin. Code § R746-100-7, Nucor Steel, a Division of Nucor Corporation (“Nucor”) hereby moves for leave to intervene in the above-referenced proceeding before the Public Service Commission of Utah. In support of this Motion, Nucor states as follows:

1. Nucor owns and operates a steel mill in Plymouth, Utah, which is served by PacifiCorp (doing business as Utah Power) under a special contract approved by this Commission. Nucor is one of PacifiCorp’s largest customers, purchasing tens of millions of kilowatt-hours of electricity per month at a cost of millions of dollars per year. 2. As a major retail customer of PacifiCorp, Nucor has a direct interest in these proceedings and the outcome will have a substantial effect on Nucor.
