| | PETITION TO INTERVENE OF UAE INTERVENTION GROUP |

Pursuant to Utah Code Ann. § 63-46b-9 and Rule R746-100-7, the UAE Intervention Group (“UAE”), consisting of the Utah Association of Energy Users, Alliant Techsystems, Chevron Corporation, ConocoPhillips, Hexcel Corporation, IHC Health Services, Inc., Simplot Phosphates LLC, Tesoro Refining and Marketing Company and Western Electrochemical Company, a division of American Pacific Corporation, hereby petition for leave to intervene in this docket.

In support of this petition, Petitioners state as follows:

1. Petitioners are large Utah electric consumers who are customers of PacifiCorp, whose rates are affected by PacifiCorp's rate structure or organizations that represent such customers.

2. The legal rights and interests of Petitioners may be substantially affected by this proceeding.

3. Petitioners have not fully determined the specific positions they will take or the relief they will seek. Petitioners seek to intervene for purposes of protecting their interests as they may appear, particularly on issues of relevance to large electric consumers.

4. The interests of justice and the orderly and prompt conduct of this proceeding will not be materially impaired by allowing Petitioners to intervene.
