MidAmerican Energy Holdings Company and PacifiCorp (hereinafter jointly referred to as the “Applicants”) hereby move the Public Service Commission of Utah (the “Commission”) to amend the revised scheduling order adopted by the Commission in this proceeding on November 17, 2005 (“Scheduling Order”). The grounds for this Motion are as follows:

1. Applicants, the Division, the Committee, the UIEC, the UAE Intervention Group, Western Resource Advocates and Utah Clean Energy are parties to a stipulation (“Stipulation”) which was filed with the Commission on November 18, 2005.
2. The Applicants, the Division and the Committee will, and other parties may, provide testimony on the Stipulation. In order to provide the Commission with an opportunity to review any testimony on the stipulation prior to the hearings, the Applicants request that the

Commission amend the revised procedural schedule as proposed in the draft Revised Scheduling Order attached hereto. The proposed change to the schedule in this proceeding adds one additional testimony filing date and does not otherwise affect the previously-scheduled testimony, discovery or hearing dates. It is not anticipated that any party will object to the proposed change.

WHEREFORE, the Applicants request that the Commission enter the Revised Scheduling Order in the form attached hereto.
