PacifiCorp hereby submits for filing an original and five copies of the IGCC Study Results provided in compliance with Commitment U 16. MidAmerican Energy Holdings Company (“MEHC”) acquired PacifiCorp on March 21, 2006. The Company will also provide an electronic version of this filing to [m.livingston@utah.gov](mailto:m.livingston@utah.gov).

In its Report and Order issued January 27, 2006, as supplemented by the Report and Order dated March 14, 2006, in the above-referenced proceeding, the Commission approved the acquisition of PacifiCorp by MEHC subject to a Consolidated List of Commitments specified in the Stipulation supported by most of the parties to the proceeding. Included in this Consolidated List is MEHC’s and PacifiCorp’s commitment regarding the filing of the enclosed IGCC Study Results. Specifically, Commitment U 16 provides in relevant part that:

U 16. \* \* \*

- (a) MEHC and PacifiCorp commit to study the economics and viability of an IGCC option and to use good faith efforts to present the results of this study as a resource alternative to inform the resource selection and RFP process under consideration in Docket 05-035-47.
