Pursuant to Utah Code Ann. 63-46b-9, and Utah Admin. Code R746-100-7 and R746-101, Questar Gas Company (“Questar Gas”) hereby respectfully petitions for intervention as a matter of right.

As grounds for its intervention, Questar Gas states the following:

1. Questar Gas is a local distribution company organized and existing under the laws of the state of Utah with authority to transact business in that state and others. Questar Gas’ principal office is located at 180 East 100 South, Salt Lake City, Utah 84111.

2. On October 6, 2005, the Utah Committee of Consumer Services (“Committee”) filed a request for agency action pursuant to Utah Code §§54-7-9 and 54-10-4 against PacifiCorp.

3. On November 4, 2005, PacifiCorp filed a motion to dismiss and answer.
4. Questar Gas has a direct interest in these proceedings. Questar Gas believes that the outcome of this proceeding may potentially have a substantial impact on the regulatory and ratemaking process of Questar Gas. Therefore, Questar Gas a direct and substantial interest in this proceeding that may not be represented by any other party.
