By the Commission:

On May 5, 2006, PacifiCorp filed a Motion for Approval of a Stipulation Regarding Schedule and Revenue Requirement Issues. The Stipulation provides proposed amendments to the procedural schedule and a procedure for the collection of amounts due for service provided between the December 11, 2006 rate effective date and the date on which the Commission issues its final order approving rates in this docket. Parties to this Stipulation are: PacifiCorp, the Division of Public Utilities, the Committee of Consumer Services, the Utah Industrial Energy Consumers, UAE Intervention Group, the Federal Executive Agencies, AARP, the Kroger Company, Roger Ball, the Salt Lake Community Action Program, Crossroads Urban Center, Nucor, Central Valley Water and the Utah Manufacturers Association.

After reviewing the Stipulation and being fully advised, the Commission approves the Stipulation with one modification. The modification we order is to the dates for test period hearings. The test period hearings in this proceeding will be held on July 26 and the morning of July 27, 2006. With that modification, we conclude that the Stipulation is fair and reasonable and is in the public interest.

ORDER

Wherefore, the Stipulation as modified is approved. The following schedule shall apply in this proceeding unless otherwise ordered by the Commission:
