Pursuant to Utah Code Ann. § 63-46b-9 and Rule R746-100-7, the UAE Intervention Group (“UAE”), including the Utah Association of Energy Users, Alliant Techsystems, Chevron Corporation, ConocoPhillips, Hexcel Corporation, IHC Health Services, Inc., Simplot Phosphates LLC, Swift & Company ~ Miller's Blue Ribbon Beef, Tesoro Refining and Marketing Company and American Pacific Corporation, hereby petition for leave to intervene in this docket.
