Pursuant to Utah Code Ann. § 63-46b-9 (1992) and Utah Admin. Code § R746-100-7, Utah Clean Energy hereby moves for leave to intervene in the above-referenced proceeding before the Public Service Commission of Utah. In support of this Motion, Utah Clean Energy states as follows:

1. Wasatch Wind filed an application with the Commission for approval of its proposed Power Purchase Agreement (PPA) with PacifiCorp as a Qualifying Facility under PURPA on April 12, 2006.

2. Utah Clean Energy is a non-profit that promotes energy efficiency and the use of renewable power in Utah and throughout the Intermountain West. As such we have a direct interest in these proceedings and the outcome may have a substantial impact on our goals.

Because of the early stage of this proceeding, Utah Clean Energy has not yet determined what, if any, positions it will take on any issues raised, or what relief it may seek to protect its interests.

3. Utah Clean Energy's interest in the outcome of these proceedings will not adequately be represented by any other party, nor will Utah Clean Energy's participation impair the conduct of the proceeding.
