By The Commission:

On April 21, 2008, at the request of the parties to this docket, the Commission issued an Order Granting Motion to Stay Procedural Schedule and to Schedule Status and Scheduling Conference along with a Notice of Status and Scheduling Conference. Together, said Order and Notice stayed the previously ordered procedural schedule for a period of 30 days to allow further settlement discussions among the parties and provided notice of a Status and Scheduling Conference set to convene on May 22, 2008.

On May 21, 2008, representatives of Rocky Mountain Power (“RMP”) informed the Commission that RMP is preparing a proposal to submit to Heber Light & Power (“HLP”) in possible settlement of this matter. RMP requested cancelation of the May 22, 2008, Status and Scheduling Conference to permit RMP to finalize its proposal and to provide HLP adequate time to consider said proposal prior to further proceedings in this matter. RMP indicates HLP does not object to cancelation of the May 22, 2008, Conference and recommends the Commission instead convene a Status and Scheduling Conference at 9:30 a.m. on June 12, 2008, as originally set by Scheduling Order issued

March 11, 2008. The Commission has determined to reschedule this conference, but to convene at 9:00 am on June 12, 2008, rather than 9:30 am.
