Rocky Mountain Power, a division of PacifiCorp (“Rocky Mountain Power” or “Company”), pursuant to Utah Admin. Code R746-100-3.A.1.a and R746-420-1(4)(c), respectfully requests that the Commission approve suspension of the All Source Request for Proposals (“2008 RFP”).

The Commission approved the Company’s 2008 RFP on September 25, 2008, subject to modifications. On October 2, 2008, PacifiCorp issued the 2008 RFP, modified consistent with the Commission’s approval order, to the market and received bidders’ proposals on December 16, 2008. Since that time, the Company, with oversight and input from Merrimack Energy Group, Inc., the Independent Evaluator (“IE”) selected by the Commission, has been evaluating the proposals to ensure that they comply with the terms and conditions established in the Commission-approved RFP.

Given the dramatic global economic downturn in late 2008 and the resulting reduction of customer loads, reduction in price of commodities, potential reduction of future construction costs and other changes in economic and market conditions, the Company has determined that it is not in the best interests of its customers to proceed with the 2008 RFP at this time. The Company believes that there is a reasonable possibility that more favorable bids may be received in the future as economic and market conditions continue to change.

Based on the foregoing, the Company intends to suspend the 2008 RFP by providing notice of suspension to bidders in the form attached as Appendix A. As noted in Appendix A, bidders may either withdraw their bids or leave their bids pending as the Company continues to assess the market over the next six to eight months. Based on that assessment, the Company anticipates that it will request bidders that have not withdrawn their bids to refresh them. The Company may also request new bids and intends to refresh its benchmark resource proposals at that time.

Accordingly, the Company respectfully requests that the Commission approve suspension of the 2008 RFP. In order for the Company to provide notice of suspension to bidders as soon as possible, the Company respectfully requests that the Commission consider this motion on an expedited basis.

The Company appreciates the efforts of the Commission, the IE and stakeholders in this process and remains committed to securing viable, cost-effective resources to meet its forecasted needs.
