Rocky Mountain Power, a division of PacifiCorp (“Rocky Mountain Power” or “Company”), pursuant to Utah Admin. Code R746-440-1(2) and paragraph 8 of the Generic Protective Order issued April 17, 2007 in Docket No. 07-999-03 (“Generic Protective Order”), hereby provides (1) a prefiling notice that it intends to file a request for waiver of the solicitation process required by Utah Code Ann. § 54-17-201, *et seq.*, with respect to acquisition of a generation plant not resulting from any pending request for proposals (“Plant”) pursuant to Utah

Code Ann. §§ 54-17-201(3) and 54-17-501 and Utah Admin. Code R746-430-4 and (2) public notice that it intends to file a request for approval of its significant energy resource decision to acquire the Plant, pursuant to Utah Code Ann. § 54-17-302 and Utah Admin. Code R746-430-2 and R746-440-1. Rocky Mountain Power intends to file the requests together (“Request”) and will not file the Request before the later of (1) five calendar days following the filing of this Notice and (2) four business days following the filing of this Notice.
