SECOND SCHEDULING ORDER FOR REVENUE REQUIREMENT AND COST OF SERVICE/RATE DESIGN

ISSUED: October 30, 2008

By The Commission:

Due to the Order on Motion to Approve Test Period, issued today, the Commission revises the schedule it previously made in the October 14, 2008, Scheduling Order for Revenue Requirement and Cost of Service/Rate Design. By Order issued August 1, 2008, these proceedings have been divided into two phases: a revenue requirement phase and a cost of service/rate design phase. The revenue requirement phase includes determination of the rate-of-return. This revised Scheduling Order affects the schedule for the two phases of the case in light of the decision we have made on Rocky Mountain Power's (RMP) request to approve a test period. The schedule for the Revenue Requirement portion of the case is revised and the schedule for the Rate of Return portion of the case is not altered by this order. The schedule for the Cost of Service/Rate Design is vacated and will be reset at a future scheduling conference.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED the following schedule shall apply:

1. Phase I -Revenue Requirement

- December 1, 2008 RMP files revisions to its base and test year data to reflect the Commission decision on test year.
- February 5, 2009 Non-Company direct testimony on revenue requirement matters shall be filed.
- March 6, 2009 Rebuttal testimony to Company and Non-Company Direct testimony shall be filed.
- March 23, 2009 Surrebuttal testimony to the March 6 Rebuttal testimony shall be filed.
- March 23, 2009 Joint Issues list and joint position matrix shall be filed.
- March 30- April 1, 2009 Hearing on revenue requirement matters will be held by the Commission beginning at **8:30** a.m., each day, in Room 403, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah.
- March 31, 2009 Public Witness Time for interested persons to provide oral comments will be held, beginning at **4:30**, in Room 403, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah.

2. Phase I -Rate of Return.

- January 8, 2009 Non-Company direct testimony on rate of return matters shall be filed.
- February 23, 2009 Rebuttal testimony to Company and Non-Company Direct testimony shall be filed.
- March 5, 2009 Surrebuttal testimony to February 23 Rebuttal testimony shall be filed.
- March 12, 2009 Hearing on rate of return matters will be held by the Commission beginning at **9:00 a.m.**, in Room 403, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah.

3. Phase II -Cost of Service/Rate Design

The prior schedule is vacated and a new schedule will be set at a future Scheduling Conference.

4. Hearings. All hearings conducted by the Commission will be open to the public, unless portions of them must be closed due to the use of Confidential Information, as provided by the Protective Order issued in this docket.

Real time broadcast of the audio portion of a Commission hearing will be available through the Commission's web site, www.psc.utah.gov. Audio files should be available at the web site after a hearing is completed.

5. Discovery. Information exchanged between parties (discovery) shall be provided within the following time periods:

Within 14 calendar days until the filing date of rebuttal testimony, for revenue requirement, rate-of-return, or cost-of-service/rate design matters as the case may be;

Within 7 calendar days beginning with the filing date of rebuttal testimony.
