**QUESTAR GAS COMPANY'S
PETITION TO INTERVENE**

Questar Gas Company (“Questar Gas”), by and through counsel, hereby petitions the Public Service Commission of Utah (“Commission”) for intervention in the above-captioned matter pursuant to Utah Code Ann. § 63G-4-207 and Utah Admin R746-100-7.

The grounds for the motion are as follows:

1. On July 17, 2008, Rocky Mountain Power (“Rocky Mountain”) filed an application to increase its retail electric utility service rates in Utah and for approval of its proposed electric service schedules and electric service regulations.

2. Questar Gas, a Utah corporation, is a public utility engaged in the distribution of natural gas primarily to customers in the states of Utah and Wyoming. Its Utah public utility activities are regulated by the Commission, and the Company’s present rates, charges, and general conditions for natural gas service in Utah are set forth in the Questar Gas Company Utah Natural Gas Tariff PSCU No. 400 (Tariff).

3. Questar Gas seeks to intervene for purposes of protecting its interests as they relate to issues, particularly regarding regulatory issues, that may substantially affect Questar Gas.

4. Questar Gas’ intervention and participation in this matter will not materially impair the prompt and orderly conduct of this proceeding.
