1. On October 14, 2008, PacifiCorp, doing business in Utah as Rocky Mountain Power ("RMP") applied for an order approving the Power Purchase Agreement ("Agreement") between PacifiCorp and Kennecott dated October 9, 2008

2. On October 21, 2008, the Commission issued a Notice of Hearing setting the hearing in this matter for December 3, 2008, at 9:30 a.m.

3. Kennecott, as a party to the Agreement whose rates for electric service will be affected by the Commission's decision in this matter, has a direct, immediate, and substantial interest in this proceeding, and the interests of Kennecott will not be adequately represented by any other party to this proceeding.
