Rocky Mountain Power, a division of PacifiCorp (“Rocky Mountain Power” or “Company”), respectfully submits this notice of withdrawal of its verified application for approval of its significant energy resource decision (“Application”) to construct and operate the Lake Side 2 generating plant.

Rocky Mountain Power filed its Application on December 3, 2008. The Application sought (i) approval of the significant energy resource decision to construct and operate Lake Side 2 and (ii) issuance of a certificate of public convenience and necessity for the plant.

Given the dramatic global economic downturn in late 2008 and the resulting reduction of customer loads, reduction in price of commodities, potential reduction of future construction

costs and other changes in economic and market conditions, the Company has determined to further explore resource alternatives. To that end, the Company delivered a formal written termination notice to each of Summit Vineyard, LLC and CH2M Hill E&C, Inc. on February 11, 2009, thereby terminating the Master Development, Engineering, Procurement and Construction Agreement (“Agreement”). Pursuant to the terms of the Agreement, the termination of the Agreement became effective on February 18, 2009. Notwithstanding termination of the Agreement, the Company remains committed to securing viable, cost-effective resources to meet its forecasted needs for summer 2012.

The Company filed notice of termination of the Agreement with the Commission on February 12, 2009. The Company appreciates the efforts of the Commission and parties to consider the Application on an expedited basis. The Company believes those efforts were justified given circumstances existing at the time the Application was filed.

Based on the foregoing, Rocky Mountain Power respectfully withdraws its Application from further consideration by the Commission in this docket and requests that the Commission close this docket.
