As indicated in the stipulation, the proposed changes have no revenue impact for existing services being delivered. The Company will complete the process of migrating the Street Lighting customers from the current Street Lighting Schedules to the ordered Street Lighting Schedules no later than thirty days following the effective date of this filing.
